- **WELCOME** (Alice Rogers)

Reminder for those who wish to pay the **NA Annual Dues** (\$15 for Single, \$ 25 for Couple). Dues are not mandatory to attend our meetings. In March we will hold our annual **NA Board Elections**. Three seats (out of 7) are up for election, each for a 2-year period. Paid Members in good standing are eligible to submit their name for consideration if Dues paid by today 2/8. We do have one resident who has stepped up to run (Sudeep Paul)

- **A Presentation for Katy Tang of the Department of Public Health regarding the City's vaccination plan.**

Katy notes that the information regarding vaccines is constantly changing. Katy reviewed the current status of the pandemic – we are as of 1/26 in the Purple Tier. Regarding the vaccine, most people will receive from their healthcare provider. The general population will likely have access to the vaccine in later 2021. Even after being vaccinated, mask wearing, social distancing, and thoroughly washing hands still need to be continued. The allocation and prioritization of vaccines is driven by the State and Federal Government, not by our own Department of Public Health. Katy reviewed the pathways of the vaccine – from the Federal to State to local facilities. Currently we are in Phase 1a + people 65 years and older for distribution of the vaccine. Katy reviewed the three phases (1a, 1b, and 1c) of vaccinations, noting that they are subject to change. Vaccinations are available thru High-Volume Vaccination Sites (thru partnerships with multi-county entities Kaiser, UCSF Health, Dignity, and Sutter), Community Vaccine Access Sites (Mobile units, hubs, and clinics), and Pharmacy partnerships (Safeway, Walgreens, CVS). There are several challenges including no clear information on when and how much additional vaccines we will receive.

Vaccination Info/Flyers for Residents of 94107

Any one 65 or older with MediCal, Healthy SF, or no health insurance, and living in 94107, 94110, or 94112 is eligible to drop by SF General Hospital 9am-3pm, and will be vaccinated if there are available doses. No appointment needed, but do need proof of age address in the zipcode (and follow up requires an email and cellphone numbers, it can be of a friend, as long as they are able to contact the recipient for the second dose), and they request MediCal or Healthy SF card if part of one of those programs. No additional proof of residency or technology required. **See flyers in multiple languages** (English on one side; other side in [Spanish](#), [Chinese](#), and [Filipino](#)).

- **SF Planning and the Greater SoMa Facilities Needs Assessment**

Svetha Ambati and Dylan Hamilton presented. The project reviews and analyzes the existing facilities and projected needs (including new facilities if needed) for the future to address a growing population in the Southeastern neighborhoods over the next 20 years. "Greater SoMa" includes SoMa, Tenderloin, Mission Bay, Showplace Square, and the "Hub" portion of Market Octavia Plan Area. "Facilities" include libraries, fire stations, public health centers, child care, recreation centers, public schools, police stations, social welfare organizations, arts and culture organizations, and facilities serving the homeless.
