# A Presentation by Assistant District Attorney (ADA) Xochitl Carrion on the "Community Liaison Program"

This is an all-volunteer program of DA staff that began in February 2021. The D6 team has 4 members: ADA Carrion is the team lead; she serves in the Hate Crime and Crime Strategies units. Team members include: ADA Sam Hadwan, a senior investigating assistant, and a leader in the Arab/Muslim community; ADA Courtney Burns, who handles Child Assault/Sex Assault and Domestic Violence matters, as well as training Police Officers in ethics, proper investigations, etc.; and ADA Ryan Khojasteh who is assigned to the juvenile center and is currently an Immigration Commissioner.

The main goal of this program is to bridge the communications gap between the community and the DA's office, to ensure community voices are being heard. The ADAs work in collaboration with law enforcement and other agencies and community organizations, as well as adjacent district supervisors. Their role is the review, charging, and prosecution of crimes presented to them by the SF Police Dept. Xochitl discussed in more detail their role and responsibilities. This includes education to the community on policy and procedure.
