In March we will hold our annual **NA Board Elections**. Three seats (out of 7) are up for election, each for a 2-year period. Paid Members in good standing are eligible to submit their name for consideration.

- **A Conversation with D6 Supervisor Matt Haney**

Supervisor Matt Haney and his legislative aide Courtney McDonald joined us for their annual visit to review and discuss various topics of concern to our residents.

Matt began with a **recap of 2020** with regards to addressing the pandemic (testing sites, mask, and PPE distribution), homeless and mental health crisis, clean and healthy San Francisco streets, aid to small businesses, corruption and scandal within our own city departments, and drug use, dealing and overdose deaths.

Matt then provided **updates** on the Mission Bay School, the Mission Bay Redevelopment Plan, the temporary Transbay Terminal site, improvements to the T-Line, the SoMa Bikeway Plan, Rincon Hill Dog Park, and his new role as the Chair of the Budget & Finance Committee.

Regarding the **Covid-19 Vaccine**, Courtney McDonald advises -- Here is what is made public so far: <https://sf.gov/covid-19-vaccine-san-francisco>. and 2) Dept of Public Health has offered to conduct presentations and answer questions at neighborhood meetings (like this!)

From Courtney McDonald: Save the Date: Thursday, February 25, 5:30PM - **Mission Bay Town Hall with Supervisor Haney**. We will send out an RSVP link next month.

From Courtney McDonald: We do not have a flyer yet for the **Small Business Webinar** the Supervisor mentioned, but it will be on Thursday 1/21 from 4-5pm. Main topics will be: PPP, Shared Spaces, and Business Fee Waivers. I will send it to Gary when we have it!

Followed by Q&A

Topics included the Embarcadero Navigation Center and the 5th/Bryant Street shelter (currently being used as an Isolation and Quarantine site due to Covid-19), Covid-19 outbreaks within the homeless population, the Mission Bay Community Realm Plan, Safe Injection sites, the need for state assistance and coordination to address homeless and mental health issues, relief for small businesses, upcoming developments in Mission Bay including the proposed Amazon distribution center and their impact on traffic congestion, plans for the 22 Fillmore route to begin serving Mission Bay, frustrations with 3-1-1 and lack of follow up.
