3. I-280 ramp proposal— The I-280 off ramp proposal being put forward by the SFCTA. A guy from San Mateo is trying to kill it and has signed on the Potrero Boosters, DNA, and the Sierra Club, among others; he's been pushing for our NA to join the opposition.
