- **A conversation with San Francisco City Attorney David Chiu**

A former San Francisco City Supervisor and California State Assemblyman, David Chiu has been San Francisco's City Attorney since 2021. He began by reviewing [what his office does](#) and the types of issues they are responsible for. Whereas the San Francisco District Attorney oversees criminal law matters involving individuals, the City Attorney is the law firm for the City and County of San Francisco. They handle civil law matters such as approving legislation and contracts, defending the City against lawsuits—and federal [executive orders that stand in opposition to City policies and agreements](#), representing the City when they bring a lawsuit, and drafting ordinances. David is one of 11 elected City Attorneys in the state of California. His office has 300+ legal professionals, and they represent 100+ city departments, boards, and commissions. They defend 3,000-4,000 lawsuits per year brought against the City. They bring lawsuits on behalf of San Francisco on such matters as Civil Rights, Climate Change, Workers' Rights, Consumer Protection and Nuisance, etc. They also enforce City and State codes.
